


2 - DAY WORKSHOP

Aim: Medicus Mundi Switzerland conducted a study to explore the experiences of MMS network members in operationalizing the human rights-based approach in the field of sexual and reproductive health. The results showed that there are some knowledge and implementation gaps on how best to apply the HRBA principles of partnership, participation and inclusion, empowerment/ capacity development and accountability/ transparency in the project management cycle of Swiss NGOs.

This workshop aims at closing these gaps by providing our network members with tools and better understanding of how best to apply a HRBA to their projects and programs. The workshop shall be participatory allowing MMS members presenting their projects. In doing so we can learn from each other's experiences.
